SOME OF YOU MAY NOT KNOW THAT MR TED THOMPSON HAS TAKEN OVER THE BARBOUR DEVELOPMENT...MR. BARBOUR STILL HAS THE ORIGINAL HOME AND CABINS....

THIS NEW PROPOSAL IS TO REZONE SO THEY CAN PUT UP **25 CONDOS**. MOST OF THEM WOULD BE ON THE NORTH END OF THE LAKE WITH FOUR ON THE NW LAKESHORE. HE ALSO WANTS SOME ON THE EAST SHORE ACROSS FROM THE CABINS, NEAR THE HUNTER TOWN LINE AND THE ORIGINAL 17 LOTS DEVELOPED BT BARBOUR/ THE LARGEST GROUP IS ON THE SITE OF THE OLD FARM NW OF THE BIG BOG.
